Subject: FMCA Review Council Election (2023-2025 term)      **SECOND REQUEST**

In accordance with FMCA's Policies and Procedures, National Directors shall submit names of recommended candidates to be considered to serve on the FMCA Review Council. As stated in FMCA's Bylaws, the FMCA Review Council shall consist of five members whose term of service shall commence following the Annual Membership Meeting in odd-numbered years. As such, successful candidates shall be elected for a two-year term. Please note the following procedures:

- ◆ Submit nominations on the included form to the National Office no later than **APRIL 30, 2023**.
- ◆ Election by the Executive Board will be held at the first Executive Board meeting following the Annual Membership Meeting on August 26, 2023. The five individuals receiving the highest number of votes shall constitute the FMCA Review Council. The Chairman of the Review Council shall be the person receiving the highest number of votes.
- ◆ The election results will be announced by mail.
